

## **GDPR PRIVACY NOTICE CUSTOMERS AND OTHERS**

### **Processing of personal data in Pangea Property Partners**

When you use our website or in other ways are in contact with us by receiving our newsletters or by the purchase of our services Pangea Property Partners will process your personal data. Below you will find information regarding which type of personal data that is being collected, the reasons for and purposes of why we collect the data and your rights regarding the processing of your personal data.

The controller of the personal data we process is Pangea Holding AB by manager / CEO Bård Bjølgerud.

Having its headquarters in Oslo, Norway, Pangea Property Partners comply with the “one-stop-shop” mechanism for supervisory authorities, hence the Norwegian Data Inspectorate (Datatilsynet) the lead supervisory authority for Pangea Property Partners.

### **1. The purposes of our data collection and what types of data we collect**

We collect and process your personal data for various purposes depending on who you are and how we get in touch with you. We collect the following personal data for the purposes mentioned below:

1. Sending out marketing materials, such as newsletters and information regarding our services: The processing is necessary for the purpose of performing a contract with you as the data subject.
2. Respond to incoming enquiries: Name, telephone number, e-mail address and other personal data collected in connection with the enquiry. The processing purpose is based on the legitimate commercial interest of helping you with your enquiry.
3. The recruitment of new vacancies and positions: CV, applications references and attestations. The processing of data is based on your given consent.

### **2. Disclosure of personal data to others**

We do not give out or disclose your personal data to others unless there is a legal obligation for such disclosure. Examples as to basis for disclosure could typically be a contract with you or legal basis in the law instructing us to provide out the information. Pangea Property Partners uses data processors to collect, store or in other way process data on our behalf. In such cases we have concluded data processing agreements to ensure the information security in all segments of the data processing. All processing of data carried out by us is done within the EU / EEA area.

### **3. Storage periode**

We only store your personal data for as long as necessary for the purpose the data was collected for.

This means for instance that personal data collection based on your consent will be deleted if you withdraw your consent. Personal data we process in the performance of a contract with you will be deleted when the contract is implemented and all obligations pursuant to the contract have been implemented.

### **4. Your rights when we process your personal data**

You have the right to obtain access to, correction and deletion of your personal data processed by us. You also have the right to obtain restriction of processing, direct objection to the processing and obtain the right to data portability. We will ask you to confirm your identity or in addition state further information before we approve your request to usage of your rights. We are doing this to ensure that we grant access to your personal data to you and not someone else pretending to be you.

### **5. Complaints**

If your opinion is that our processing of your personal data is not in compliance with the described manner here or in other ways not in compliance with the general data protection regulation, (GDPR) you can file a complaint to the Norwegian Data Protection Authority (Datatilsynet).

### **6. Changes**

If there should be a change in our services or a change in the regulation regarding the processing of personal data, this can cause changes in the information given in this notice. If we have your contact information we will make you aware of these changes. In all cases updated information will always be easily accessible on our web pages.

### **7. Cookies**

In order to obtain information regarding the use of our web pages we use cookies. The processing of cookies is based on the commercial interest of adjusting our web pages for the benefit of users. We ensure your data protection by only using this information for statistical purposes. In this statistic it is not possible to identify you as an individual. We delete collected personal data on a daily basis.

We also use third-party Google Analytics to monitor and analyse the use of our Service. Google Analytics is a web analytics service offered by Google that tracks and reports website traffic. Google uses the data collected to track and monitor the use of our Service. This data is shared with other Google services. Google may use the collected data to contextualize and personalize the ads of its own advertising network.

You can opt-out of having made your activity on the Service available to Google Analytics by installing the Google Analytics opt-out browser add-on. The add-on prevents the Google Analytics JavaScript (ga.js, analytics.js, and dc.js) from sharing information with Google Analytics about visits activity.

<b>Cookie name</b>	<b>Default expiration time</b>	<b>Description</b>
_ga	2 yrs	This cookie is used to distinguish unique users by assigning a randomly generated number as a client identifier. It is included in each page request in a site and used to calculate visitor, session and campaign data for the sites analytics reports.
_gid	24 hours	Also used to distinguish users
_gat	10 minutes	This cookie name is associated with Google Universal Analytics, according to documentation it is used to throttle the request rate - limiting the collection of data on high traffic sites.
_icl_current_language	90 days	Cookie used by Wordpress to set the language on the web-page.
